FRESH PRODUCE, DAIRY AND HOT MEALS. THIS PROGRAM WAS LAUNCHED TO
RESPOND QUICKLY TO THE COVID-19 PANDEMIC. FIVE MILLION POUNDS OF FOOD
WERE DISTRIBUTED TO OVER 220 CITIES IN AMERICA AS WELL AS MANY
COUNTRIES ABROAD. THE SUSTAINABILITY PROGRAM WAS DESIGNATED FOR FOOD
